COUN. WILSON A. VIRAY – Ang Calamity ba na ito ay QRF?

JOERY M. GEROLEO – P2.7M ang QRF.

COUN. WILSON A. VIRAY – Food at sardines ang pinaggamitan pero sa pagkain ay konti lang.

JOERY M. GEROLEO – Ang 30% ng calamity fund ay mandated by law as QRF.

COUN. WILSON A. VIRAY – Gaano karami agad ang stockpile?

JOERY M. GEROLEO – 100 cavans na bigas. Iyong QRF ay magagamit lang kung may declaration ng calamity. Iniwasan natin na kung marami ang stockpile ay uumukin lamang. Ang NFA ay 100 cavans lang per day ang pwedeng bilhin sa kanila.

COUN. WILSON A. VIRAY – Wala ba kayong advice ng bagyo? May communication ba kayong natanggap mula sa PDRRMO?

JOERY M. GEROLEO – Pabago-bago ang forecast ng PAGASA ng bagyo ang sabi nila ay nasa Bicol ng Sunday, pumasok sa PAR ay Sunday na.

JOERY M. GEROLEO – 8,400 ang report ng damaged houses sa 52 barangays, may 18 barangays na hindi pa kasama. Iyong kinukuhan natin bigas, sardines, noodles, iyon po ay doon ibabawas sa P2M.

COUN. LEO G. DE VILLA – Ang barangay ba ay naging ready?

JOERY M. GEROLEO – May mga report naman po na meron silang stockpile.

COUN. LEO G. DE VILLA – Maraming lumikas sa mga barangay, hindi ko naramdaman na mayroong ayuda mula sa pamahalaan para magkaroon din ng command ang bawat barangay.

JOERY M. GEROLEO – Pwede tayong bumili pero pahirapan naman sa pagbili. Kalakasan na ng bagyo noong December 15 at inabot na ng bagyo sa Curva ang ating bigas. Pwede po na i-full blast ang 30% QRF ang problema ay wala nang mabili.

COUN. LEO G. DE VILLA – Ang naging problema kasi last year ay ang COA.

COUN. CANDIDO J. MELGAR, JR. – Wala kasing declaration last year.

JOERY GEROLEO - Hindi din po kasi tayo mag-stockpiling ng madami dahil for bidding na ito. Kapag more than P100,000.00 ay for bidding pa.

COUN. WILSON A. VIRAY - May MOA naman tayo sa NFA during calamity, Bakit nagti-tyaga pa tayo sa NFA ay pwede naman pala sa iba dahil ibi-bid din pala?

COUN. GREAT M. DELOS REYES - Kapag ang halaga ay kalahapas ng P100,000.00 dadaan ito sa bidding. Kung bibili sa labas magkakaroon din ng bidding. Ang forecast ng PAGASA ay tatama dito sa atin ng Wednesday, 12:00 p.m. pero tumama ng Marles at 10:00 a.m. So, wala na tayong magagawa.

COUN. LEO G. DE VILLA - Bakit tayo matatakot sa COA kung tatama naman sa atin ang bagyo. Paano kung kailangan ng mga tao? Depensahan na lang natin.

COUN. CANDIDO J. MELGAR, JR. - So, nagamit na ang 70% para sa preparedness. Stockpile na 140,000 na bigas, noodles at sardines. May magagamit pa tayo na P2.7M, ilan na ang nagamit out of that?

JOERY M. GEROLEO - Ang nagamit ay about P500,000.00.

COUN. CANDIDO J. MELGAR, JR. - Ilan pa ang kailangan natin?

ABSTENENCIA C. DE GUZMAN - Mga P3M pa ang kailangan for food.

FLOOR LEADER - Kulang na tayo ng P3M para sa food assistance. Magkano po ang kailangan para sa shelter?

ABSTENENCIA C. DE GUZMAN - P26M ang kailangan for shelter assistance para sa 52 barangays.

COUN. CANDIDO J. MELGAR, JR. - May P5.7M tayo for next year.

COUN. LEO G. DE VILLA - Papaano ang preparedness. Hindi pwedeng gamitin lahat ang pondo by next year.

COUN. CANDIDO J. MELGAR, JR. - P29M ang kailangan natin sa ngayon and yet P2.7M lang ang mayroon tayo ngayon.

PRESIDING OFFICER PRO TEMPORE - We still need P29M, P3M for food and P26M for shelter assistance. Question from the Chair, mula sa anong district lyong hindi pa nakakapag-submit ng report? Ano ang sitwasyon ng area, passable na ba?

JOERY M. GEROLEO - Motorsiklo pa lang po ang pwede. Ang Barangay San Andres at Barangay Malvar ay hindi pa po napupuntahan.

ABSTENENCIA DE GUZMAN - Mayroong tayong apat na casualty.

COUN. EDGAR IBRAHIM C. LLAMAR, MD. - Hindi ba naisama ang Metolza at Evangelista?

ABSTENENCIA C. DE GUZMAN - Metolza ay wala pang report, pero sa Barangay Evangelista ay mayroon na.

COUN. CANDIDO J. MELGAR, JR. - Kaugnay ng Supplemental Investment Program No. 3, may pangangailangan ba talaga para i-reconsider ng MDC. Ano ba ang dapat kalagayan ng pondo?

ABSTENENCIA C. DE GUZMAN - Ang plano namin ay materials assistance. Ilinatanong din namin kung saan galing ang bahay.

COUN. GREAT M. DELOS REYES - Ano ba ang plano sa pamimigay? Paano ang pagkukwenta ng damages?

ABSTENENCIA C. DE GUZMAN - P3,000.00 sa totally damaged, P1,000.00 sa partially damaged. May pipimahan sila na form na kung wala ito hindi sila mabibigyan. Bago matapos ang assessment ay one and one half (1 1/2) months kapag sa atin galing ang pondo.

COUN. GREAT M. DELOS REYES - Talagang kailangan ng tao ang ayuda, huwag na kung patagalin.

COUN. CANDIDO J. MELGAR, JR. - Ilan ang tao ninyo? Sa partial report ay 8,412 in 52 barangays.

ABSTENENCIA C. DE GUZMAN - 10 kami kasama ang 3 job order personnel, makikipag-coordinate kami sa Regional Office.

JOERY GEROLEO - Sa Calapan NFA Buying Station.

COUN. CANDIDO J. MELGAR, JR. - (Reads provisions of the MOA with NFA.) Kung magkakaroon ng revision sa SIP, sa shelter assistance ilalagay not on food.

ABSTENENCIA C. DE GUZMAN - Yes po.

COUN. EDGAR IBRAHIM C. LLAMAR, MD. - We have to do something, ineffective ang NFA. Dapat gumawa tayo ng paraan dahil nagugutom ang ating mga kababayan.



We are not saying to change this into calamity related supplies. We are asking for reconsideration to make SIP No. 3 responsive when programs and activities will be allocated. We are just saying to return. Recommendation is to return the SIP No. 3. It is the job of the MDC to re-submit the Supplemental Investment Plan. In times of calamity, even the procurement law, some sections pwede silang without bidding. We can purchase directly even without bidding.
